# **Appointment of Panel Members**

The Takeovers Panel welcomes the recent announcement by the Minister for Financial Services, Superannuation and Corporate Law of the reappointment of 11 members and the appointment of 10 new members to the Panel, for a term of 3 years commencing 8 March 2010.

The President of the Panel, Mr Simon McKeon, said that the Panel's success is due largely to the time and expertise contributed by busy and distinguished professionals.

"As we celebrate the 10<sup>th</sup> anniversary of the Panel in its current form, it is important that we recognise that the Panel's success is due largely to the skills, input and support of very capable and committed members", Mr McKeon said.

"My thanks go to those members of the Panel whose terms are ending. Each of them has made a significant contribution to the Panel by making it a priority, in their busy schedules, to sit on matters and assist in the development of policy."

Mr McKeon added: "In the last 10 years we have decided over 300 applications, and dealt with novel issues. In doing so, we have freed up considerable court time. Takeovers regulation in Australia is at the forefront of international best practice."
